#### SUMMER'S OVER – A GOOD TIME TO REVISIT RV, BOAT & TRAILER PARKING RULES

This summer we saw numerous RV parking violations. Let's review the RV parking rules and the methods for reporting parking violations.

The Thousand Oaks municipal code permits RV parking on residential streets for 72 hours and in driveways for 30 days. The Oakridge Estates Community Association's Rules and Regulations limit parking to 72 hours whether on streets or driveways. The homeowner is obligated to observe both City code and Association rules.

The Board of Directors knows that there will be occasions when your need to load or unload your RV will coincide with the drive-through by the Management Company. To avoid a violation letter, please call the Management Company and let them know when you will be loading or unloading.

We know that for some following these rules is an inconvenience. Nevertheless, they must be observed.

You may report violations to the Management Company or to the City's Vehicle Abatement Hot Line at (805) 371-8379.

With everyone's cooperation, we can eliminate this problem.

#### WATCH YOUR SPEED

Speed limits throughout Oakridge Estates are 25 mph, except on Lesser Drive near Reino Road. Be sure to slow down as you move from the 35 to the 25 mph zone.

Within the past year a child and a dog were struck by cars in which speeding may have been a factor. With the new school year underway, we all need to be very conscious of our speed.

If you have a problem (like speeding) in your neighborhood, you can call the Thousand Oaks Police Department Traffic Bureau at (805) 494-8271 and they will work with you to find a solution.

#### **COMMERCIAL VEHICLES**

If you own a vehicle that is used for work – e.g., it contains signage on it that identifies a company, or contains racks or ladders, then it is a commercial vehicle. Such vehicles may *not* be parked on an Oakridge Estates street overnight. There are *no* exceptions.

Any homeowner may report such violations by calling the Management Company.

#### **BOARD VACANCIES**

Board elections are only three months away. Early this year, Diane Doria resigned from the Board, leaving an unfilled vacancy. Due to other commitments, some current Board members may not run again, creating additional vacancies.
