TANDEM TAKES THE REINS

As stated in our financial letter, Tandem Property Management Inc. has taken over the responsibilities for managing our HOA. The Board of Directors sent out requests for quotes to 16 companies. Five responded and three were interviewed. Tandem was chosen because they had the best coverage at the least expense. Contact information for Tandem is provided at the end of this newsletter.

ANNUAL MEETING

At the Annual Meeting on January 26, 2006, the Association will decide several important matters.

A vacant post on the Board needs to be filled; if you are interested in being on the Board please contact the Management Company (see below) as soon as possible.

Around the first week in January, the Management Company will send out proxy cards. Please take the time to fill in your card. Either vote for the candidates or allow someone else to vote for you. Even if you decide to allow someone else to be your proxy, you can always show up at the meeting and vote in person. If you have questions regarding the proxy please call the Management Company.

The members of the Rules and Regulations Committee and the Architectural Change Committee are working hard to complete their work on updating these documents so that homeowners can vote on these changes on the January ballot.

At the end of each year we vote to transfer excess funds in the operating account to the operating account for the new year. This is an important vote as it directly affects how much we pay in income tax.

ARCHITECTURAL COMMITTEE OPENINGS

The Architectural Committee meets about once every three weeks to review and approve architectural requests submitted by homeowners. The meetings last from 20 minutes to an hour and the meeting time and date are determined by the availability of the committee members.

There is currently one opening on the committee for a permanent member and one opening for an alternate member. We encourage any interested homeowners to apply. The Board of Directors will review all applications and appoint the new members to the committee. Please contact the Management Company for an application form. Deadline to apply is December 15, 2005.

MONTHLY BOARD MEETING CHANGES

Starting in 2006, Oakridge will increase its HOA meeting schedule from 6 to 12 per year. The exact dates have not yet been fixed. See the box below for the near-term meeting schedule. Meetings will continue to be held at 7 pm at Casas de la Senda Clubhouse at 3778 Cabrillo Ave.

Until then, if you need Architectural Request forms, a list of approved paint colors, or other information previously posted on the Web, email or call the Management Company and they will promptly send or email the information to you.
