LANDSCAPE IRRIGATION SURVEY REPORT

The Oakridge Estates Landscape Committee scheduled a landscape irrigation survey study for the Association's common areas with WaterWise Consulting, Inc. and California American Water. In this study WaterWise, Inc. inspected irrigation heads, timers, controllers and coverage and prepared a report evaluating the efficiency of the Association's

irrigation system and providing recommendations to decrease irrigation deficiencies to conserve water and lower expenses. The Landscape Committee and the Board of Directors are reviewing the survey report and taking steps to help Oakridge Estates become more water wise.

INSTALLATION OF IRRIGATION SMART CONTROLLERS

The Board of Directors approved the installation of irrigation smart controllers for the common area landscaping. These smart controllers use weather satellite information to determine irrigation run cycles. It is anticipated that these smart controllers will decrease water consumption by nearly 30%, representing significant savings to the Association.

GOVERNING DOCUMENT UPDATES

The Board of Directors is in the process of reviewing the final draft of the Governing Documents before they are sent out to the membership for review and feedback. You should be receiving your draft sets in March.

Because homeowners are encouraged to become active participants in updating the Association's <u>CC&R's</u> and <u>ByLaws</u>, the Board of Directors have decided to create a Governing Document Update Committee, made up of homeowners, to assist in the updating and approval process.
