The association's newly updated CC&Rs have officially been approved by the court and recorded. The new CC&Rs will be distributed to Homeowners within the next 30-60 days. In the interest of saving the association a significant amount of money, homeowners who would like to receive the new documents electronically, via CD ROM, must complete the consent form included with their April statement and return it to Property Management Professionals.
